# THE TRAFFIC AND ROAD SAFETY ACT, 1998 (AMENDMENT) ACT, 2022

An Act to amend the Traffic and Road Safety Act, 1998 Cap. 361, by substituting for the word "date", the word "year" in sections 14A and 14B; by repealing paragraphs (a), (b) and (f) of section 178; by substituting for the word "Board" wherever the word appears, the words "Competent Authority"; by substituting for the words "Secretary to the Board" wherever the words appear, the word "Commissioner"; and for related matters.

BE IT ENACTED by Parliament as follows—

#### 1. Commencement

This Act shall come into force on 1st July, 2022.

#### 2. Amendment of Traffic and Road Safety Act, 1998

The Traffic and Road Safety Act, 1998 Cap. 361 in this Act referred to as the principal Act is amended in section 2 (1), by inserting immediately after the definition of "chief licensing officer" the following—

"Commissioner" means the Commissioner responsible for Transport Regulation and Safety;"

#### 3. Amendment of section 14A of principal Act

Section 14A of the principal Act is amended in subsection (1), by substituting for the word "date", the word "year".

#### 4. Amendment of section 14B of principal Act

Section 14B of the principal Act is amended in subsection (1), by substituting for the word "date", the word "year".

#### 5. Amendment of section 178 of principal Act

Section 178 of the principal Act is amended in subsection (2), by repealing paragraphs (a), (b) and (f).

#### 6. Miscellaneous amendments to principal Act

The principal Act is amended—

- (a) by substituting for the word "Board" wherever the word appears, the words "Competent Authority"; and
- (b) by substituting for the words "Secretary to the Board" wherever the words appear, the word "Commissioner".

#### 7. Amendment of Fourth Schedule to principal Act

The principal Act is amended in the Fourth Schedule by substituting for the word "date" wherever the word appears, the word "year".
