Museveni 'sinned' in recalling Odoki from retirement - MPs

PARLIAMENT. Lawmakers and lawyers yesterday said the President committed an "unforgivable sin" by recalling Chief Justice Benjamin Odoki from retirement.

But their anger did nothing to dampen Attorney General Peter Nyombi's insistence that Mr Museveni acted within his powers in re-naming Mr Odoki to head the Judiciary.

Justice Odoki's willingness to take a parttime job in Swaziland and at the same time head Judiciary back home, was also deplored as an act of "greed".

While it is not yet clear whether Justice Odoki has accepted President Museveni's job offer after he clocked 70 years in March and also served the transitional three months, he had earlier circulated a concept paper calling for re-appointment of retired judges.

The concept paper, written on April 26, talks about appointments in the Judiciary, including tenure of judges, re-appointment of retired judges, appointment of acting chief justice, acting deputy chief justice and acting principal judge. It also discusses a proposal to raise the age of retirement and the proposal to appoint ex-officio judges in the appellate courts.

In the paper, Justice Odoki cites Articles 142 (2) and 253 (1) of the Constitution to argue that judges who have reached retirement age should still be eligible for reappointment. This is the same Article cited by Mr Nyombi while defending President Museveni's decision.

However, it is not clear whether Justice Odoki will appear before the House Appointments Committee for approval, since that requirement is provided for under Article 142 (1) as a general principle for the appointment of judicial officers.

In part, Article 142 (2) reads: "The President may, acting on the advice of the Judicial Service Commission, appoint a person qualified for appointment as a Justice of the Supreme Court or a Justice of Appeal or a Judge of the High Court to act as such a justice or judge even though that person has attained the age prescribed for retirement in respect of that office."

Speaking in his private capacity, the secretary Uganda Law Society, Mr Nicholas Opio, said being a judge should not be a part

time work much less for a Justice of the Supreme Court, the highest and last appellate court in the country.

To do so, he added, "is to show utter contempt and disregard for the jurisprudence, users of the court and the Supreme Court

"Even though he was not appointed to the Swaziland Supreme Court bench, Justice Odoki should not participate in desecrating a constitutional order he so painstakingly took part in developing. It would really be like raping ones own daughter," Mr Opio

The MPs said the Constitution does not envisage an appointment on acting capacity of a chief justice who has retired on account of the mandatory retirement age. The best Mr Odoki can settle for and which is legal, they said, is being an acting justice of the Supreme Court.

Shadow Justice Minister, Medard Ssegona said: "It's an illegal posting. The Chief Justice position has an age limit. Museveni is only setting a precedent for himself and all we shall see is him renewing his contract. He is setting a precedent for himself because he wants to serve beyond the age limit."

Paul Mwiru (FDC, Jinja East): "It's up to Odoki to make himself relevant or irrelevant but history will have to judge him. The challenge is not about Museveni because he is trapped in power and wants to survive but the chief justice must be sober enough to resist any kind of temptation.

Eddie Kwizera (NRM, Bufumbira):

"The President must tell us if he has extended his term. Has he done so according to the law? Is he acting judge and can he be Chief Justice? Government should come out and clarify."
