A Bill for an Act

ENTITLED

THE SUPPLEMENTARY APPROPRIATION ACT, 2012.

An Act to make supplementary appropriation out of the consolidated fund under section 16 of the Public Finance and Accountability Act, 2003 of a sum of six hundred thirty eight billion four hundred fifty five million and fifty one thousand shillings only to meet additional expenditure for the first, second, third and fourth quarters of the financial year 2011/2012.

BE IT ENACTED by Parliament as follows:

1. Supplementary appropriation.
