#### A Bill for an Act

### **ENTITLED**

## THE SUPPLEMENTARY APPROPRIATION ACT, 2015.

An Act to make supplementary appropriation out of the Consolidated Fund under section 25 of the Public Finance Management Act, 2015, of a sum of five hundred and thirty three billion, five hundred and twenty one million, three hundred thousand, five hundred and ninety shillings only to meet additional expenditure of the financial year 2014/2015.

BE IT ENACTED by Parliament as follows:

# 1. Supplementary appropriation.

The supplementary appropriation out of the Consolidated Fund in respect of the first, second, third and fourth quarters of the financial year 2014/2015, for the purposes specified in column 1 of the schedule to this Act, of the sums respectively specified in column 2 of that Schedule, is hereby allowed and confirmed.
