THE SUPPLEMENTARY APPROPRIATION (No. 3) ACT, 2022

An Act to make supplementary appropriation out of the Consolidated Fund under Article 156(3) of the Constitution and Section 25 of the Public Finance Management Act, 2015 of a sum of four trillion, seven hundred twelve billion, nine hundred fifty nine million, three hundred sixty two thousand shillings only to meet additional expenditure for the Financial Year 2020/2021.

BE IT ENACTED by Parliament as follows:

1. Supplementary appropriation

The supplementary appropriation out of the Consolidated Fund in respect of the first, second, third and fourth quarters of the financial year 2020/2021, for the purposes specified in column 1 of the Schedule to this Act, of the sums respectively specified in column 2 of the Schedule, is hereby allowed and confirmed.

2. Commencement

This Act shall be deemed to have come into force on the 1st day of July, 2020.
