The object of this Bill is to amend the Traffic and Road Safety Act, Cap 361, by substituting for the word "date" the word "year" in section 14A and 14B; by repealing paragraph (a), (b) and (f) of section 178; by substituting for the word "Board" wherever it appears, the word "Competent Authority"; by substituting for the words "Secretary to the Board" wherever it appears, the words "Commissioner"; and for related matters.

A Bill for an Act

ENTITLED

THE TRAFFIC AND ROAD SAFETY (AMENDMENT) ACT, 2022

An Act to amend the Traffic and Road Safety Act, Cap. 361, by substituting for the word "date" the word "year" in sections 14A and 14B; by repealing paragraph (a), (b) and (f) of section 178; by substituting for the word "Board" wherever it appears, the words "Competent Authority"; by substituting for the words "Secretary to the Board" wherever it appears, the words "Commissioner"; and for related matters.

BE IT ENACTED by Parliament as follows—

1. Commencement

This Act shall come into force on 1st July, 2022.

2. Amendment of the Traffic and Road Safety Act

The Traffic and Road Safety Act, Cap. 361 in this Act referred to as the principal Act is amended in section 2 (1), by inserting immediately after the definition of "chief licensing officer" the following—

"Commissioner" means the Commissioner responsible for Transport Regulation and Safety;"

3. Amendment of section 14A of principal Act

Section 14A of the principal Act is amended in subsection (1), by substituting for the word "date" the word "year".

4. Amendment of section 14B of principal Act

Section 14B of the principal Act is amended in subsection (1), by substituting for the word "date" the word "year".

5. Amendment of section 178 of principal Act

Section 178 of the principal Act is amended in subsection (2) by repealing paragraph (a), (b) and (f).

6. Amendment of the principal Act

The principal Act is amended—

- (a) by substituting for the word "Board" wherever it appears, the word "Competent Authority"; and
- (b) by substituting for the words "Secretary to the Board" wherever it appears, the word "Commissioner";

7. Amendment of Fourth Schedule to principal Act

The principal Act is amended in the Fourth Schedule by substituting for the word "date" wherever it appears, the word "year";
