
**SUBMISSION OF THE ADDENDUM TO CORRIGENDA TO THE DRAFT
BUDGET ESTIMATES FOR TREASURY OPERATIONS FY 2018/19**

Reference is made to my earlier letter dated 9th May, 2018 submitting Corrigenda to the Draft Budget Estimates for FY 2018/19 in Parliament on 9th March 2018.

However, at the end of June, 2017, Bank of Uganda registered a deficit of **Ushs. 17 billion**. Also, the projected financial performance for the year ending June 2018 indicates that the Bank will incur operating losses amounting to **Ushs. 457 billion** (mainly on account of monetary policy and currency costs), bringing accumulated losses to **Ushs. 474 billion**. This projected deficit in the core capital position, together with the required core capital position of **Ushs. 30 billion** (as provided in the Bank of Uganda Act) puts the additional recapitalization securities to the tune of **Ushs. 504 billion**.

The purpose of this letter, therefore, is to:

- i) Submit the addendum to corrigenda to the Budget Estimates FY 2018/19 amounting **Ushs. 504 billion** for Recapitalization of Bank of Uganda; and
- ii) Request you to make arrangements for the Hon. Minister of Finance, Planning and Economic Development to lay the Corrigenda before Parliament.
